42nd CIECA CONGRESS Assessment for novice driver safety Budapest, 4 June 2010

Opening by CIECA President Sonja Sporstøl

Good morning ladies and gentlemen,

Dear Mr President, Dear representatives of the European Commission, Dear Members,

It is a great pleasure for me to welcome you to CIECA's 42nd Congress on assessment for novice driver safety. I am delighted to see you so numerous here today in this city full of history and tradition. We all know that young people are over-represented in accidents and in Europe more than 6,500 young people were killed in 2008¹. A mixture of inexperience and overestimation of one's driving abilities often proves to be fatal in the age group of 18 – 24-year- old male drivers. Any effort to better prepare learner drivers for the challenges on the road and improve their self-assessment abilities is an important step towards saving lives. In light of this background later on today we will therefore specifically look at risk and how assessment can contribute to the reduction of risk for young drivers.

And finally, valid and reliable theory and practical testing is one of CIECA's core competences. As a driving test association our members are in most cases
