The Choices We Made



- Option 2 Assessment
- Implemented in consultation with our social partners
- Modular Approach for the Initial Qualification
- That NVT can be used for up to 1 year
- A DQC as proof of CPC Status
- Investment in a Recording and evidencing Database for Periodic training
- Toughen up the licence acquisition tests for drivers who are exempt from CPC

The Initial Qualification Module 1



- 100 Multiple Choice Questions
- 20 Hazard Perception Questions
- Up to 4 Hours permitted
- Can be taken as two separate events
- Special accommodations
- Pass mark M/C 85/100 : HPT 67/100
- Pass Rate 80%
- Fee M/c £35 (€40): HPT £15 (€17)



Module 2 Case Studies



- 50 Questions contained in up to 8 case studies
- Psychometrically valid
- Written by Industries' Subject Matter Experts
- Up to 1.5 Hours permitted
- Pass mark PCV 40/50 : LGV 38/50
- Pass Rate PCV 55% : LGV 67%
- Fee £30 (€34)



Module 3 Practical Test



- Lasts 1.5 Hours
- Show me, Tell Me test of safety
- Off Road manoeuvres
- On Road test of driving Minimum of 1 Hour
- Includes eco-driving
- Pass Rate 52% (PCV), 51% (LGV)
- Fee £115 (€130)



Module 4 Demonstration of Vehicle Safety



- Lasts 0.5 Hours
- Explanation and Demonstration
- Static equipment or vehicle used for test
- Item Bank developed with Industries' Subject Matter Experts
- Can be taken at the same time as Module 3
- Pass mark 15/20 in each of the 5 topic areas with an overall score of 80/100
- Pass Rate 84%
- Fee £55 (€63) (includes the cost of the DQC)



Module 4 Load Securing Demonstration



- Load Securing Demonstration Trolley (LSDT)
 - Trolley comes in two parts
 - Assembled trolley dimensions 918mm wide,
 - 460mm deep, 1815mm high (including wheels)
 - 5 load securing tools, stored in trunk of trolley
 - Weighs 85kg (including tools)
- •Design engineering drawings for the LSDT have been made freely available by the Driving Standards Agency. There is no formal requirement for a training body to use one of these trolleys.





NVT Concession



- NVT course must last minimum of 6 months/maximum 3 years
- GB Concession 1 year
- NVT must be formally evidenced
- Card issued costs £25 (€28)
- Concession granted only once
- Not big take up



Periodic Training Provision of Courses



- Approvals Unit established with social partners
- Centres Approved £1500 for 5 years
- Courses Approved/Re-Approved £36 per hour
- Courses range from 7 to 35 hours
- Quality Control centres audited average of 1 2 times each 5 year period
- Risk ratings aligned
- Instructors
- Approved public courses advertised on website
- Drivers record of hours uploaded to Recording and Evidencing system by training provider

- Eco-Driving and Periodic Training
- Agree arrangements for periodic training taken in other jurisdictions
- Communications with Industries and their training providers
- Simulators
- Analysis of Case Study Pass Rates
- Employers to view drivers information and comply with the DPA
