THEORETICAL TEST IN 3 PARTS

A. Multiple choice questions (100 = 50 driving licence + 50 CPC)

- duration: 100 minutes
- minimum score: 80/100 (40/50 driving licence + 40/50 CPC)

B. Case studies (8 = 40 multiple choice questions)

- duration: 80 minutes
- minimum score: 32/40

C. Oral test (10 questions)

- duration: 60 minutes
- minimum score: 80/100

PRACTICAL TEST IN 3 PARTS

A. Test on private ground

- duration: 15 minutes
- 4 basic manoeuvres

B. CPC-test

- duration: 30 minutes

C. Test on public roads

- duration: 90 minutes

A. Multiple choice questions : € 52

COST PRACTICAL TEST

A. Test on private ground :

- C1, C, D1, D : € 37
- C1E, CE, D1E, DE : € 48

B. CPC-test : € 54

C. Test on public roads : € 128

OTHER COSTS

- A. Delivery of the driving licence with code 95 by the municipality : € 11

- B. Medical examination : € 135 maximum

- C. Preparation of the test via driving school, manual,... : € ???

REFUND C1, C, C1E, CE VIA SOCIAL FUND

A. Driving licence + CPC :

- C : € 700
- CE : € 950

B. Medical examination : € 95

REFUND D1, D, D1E, DE VIA SOCIAL FUND

A. Driving licence + CPC :

- € 700

COSTS

- A. Working time of the driver following the training
- B. Replacement cost of the driver following the training
- C. Delivery of the driving licence with code 95 by the municipality : € 11
- D. Training cost : € ???

Periodic training in Belgium



REFUND C1, C, C1E, CE VIA SOCIAL FUND

A. Working time :

- paid at 100%
- no refund

B. Training cost :

- approved training plan
- € 25 per driver and per year (€ 50 for companies with maximum 5 workers)

REFUND D1, D, D1E, DE VIA SOCIAL FUND

A. Working time :

- paid at 100%
- 50% refund

B. Training cost :

- own training institute
FCBO

FOR C, C1, CE, C1E, D, D1, DE, D1E IN SME'S

A. Flanders: KMO-portefeuille (SME-wallet) for training

B. Wallonia: training checks

C. Brussels: no intervention
