Abstract

How best should we train drivers to cope with increasing levels of autonomy? Drive 2Thefuture is a 3.9Million Euro project backed by the EU that aims to answer that question. It will assess the needs, wants and behaviours of drivers and automated users today and in the future. It involves 31 Partners from 13 European countries; through 9 interrelated work packages, over 36 months and started last October.

Our presentation will start with an introduction to the Drive2the Future project. Drive2theFuture's mission is to prepare "drivers", travellers, and vehicle operators of the future to accept, and use connected and automated vehicles. The project aims to define the needs and wants of these users and ensure that vehicle makers meet these needs. It will do this by modelling and simulating best practice in Human Machine Interface and developing specialised training tools. There will be 12 Pilots across Europe using simulators, test tracks and real-world environments plus at least 3 major demonstration events.

Drive2thefutre will be surveying EU citizens to assess user acceptance and identify training needs. The project will also develop training approaches, HMI concepts, incentives, policies, and other cost-efficient measures to promote their pilot study findings. This is where driver training organisations such as CIECA will be a key audience that we want to engage with from an early stage in the project. IAM RoadSmart is one of the 31 partners in the project, and we have been specifically tasked with two workstreams. Firstly, to develop a training package for driver trainers built on what is learned in the simulator studies. Feedback from CIECA members on this would be critical to its success. Secondly, with developing a business plan for the wider public facing training programmes that are developed from the pilot studies. We plan to do this by initially surveying professional driver training organisations across Europe to assess their state of readiness, opinions, and ideas for the future of driver training in a time of ever-increasing automation. By the time of the 52nd Congress we will have conducted the first phase of this market research and a key part of our presentation will be an analysis of the results. The feedback from this first questionnaire sent to professional bodies will then be used to facilitate a discussion at the Congress as we present progress reports on the Pilot studies and our initial thinking on the best way forward. Our aim being to always bring the driver training industry along with us.
